I also fully realize and appreciate that exposure to cats may result in allergies or other injuries even if no biting or scratching takes place. Finally, I realize that my child's participation will require his/her presence in public facilities, and that he/she will be subjected to such accidental injuries or illnesses as may from time to time occur to members of the public present in such facilities. I execute this Release and Waiver in belief that the potential benefits to my child resulting from his/her participation in the CFA Youth Development Program outweigh the risk of illness or injury involved, and I fully understand that the execution of the Release and Waiver is a condition of my child's participation in the program.
